



## ADOPTION/PURCHASE CONTRACT

1. We, Tiny Titans Cattery, affirm that the kitten being adopted/purchased is a purebred Maine Coon with an accurate Pedigree and can be registered with The International Cat Association (TICA)
2. Said Maine Coon kitten is being sold as a \_\_ PET\_\_ only, with no breeding rights.
3. Breeder Consents for kitten to be shown as a \_\_PET\_\_ in any eligible spayed/neutered class of CFA or TICA pet/cat show.
4. We, Tiny Titans Cattery, affirm that the kitten being adopted/purchased is in Good Health.

Kittens veterinarian record/s will be provided to Buyer upon kitten's delivery/pick-up.
5. A Veterinarian, of your choosing, must evaluate the kitten within 72 hours from the date purchased. If any issues or concerns are found by said veterinarian, they need to be immediately reported to the breeder, in order to honor this contract on Buyer's end.
6. Deposits for Reservation of kitten/s are NON-REFUNDABLE.
7. Upon kitten delivery/pick-up- any transportation costs, veterinarian expenses and/or other financial expenses in association with said kitten, are the responsibility of the buyer and *WILL NOT BE REFUNDED* by the breeder.
8. Breeder requests that each kitten/cat have a yearly veterinarian evaluation veterinarian recommended vaccinations, including rabies, as well as a yearly dental cleaning, if needed.
9. At no time in the life of said kitten/cat will they be declawed.

If a change in diet is done by Buyer, Buyer agrees to introduce the new food in a slow, gradual process in order to avoid digestive upset, and help them adjust to the new food's taste, texture, and ingredients. Gradual introduction allows their digestive system to adapt, minimizing the risk of issues like diarrhea or vomiting.

11. When said kitten is received by Buyer, it is THEN the Responsibility of the Buyer. The Buyer agrees from this point in time to indemnify the seller from any claims directly or indirectly involving the Kitten/Cat, regardless of the nature of the claim. In the event of any claim or dispute, the court jurisdiction will be in Pickaway County, Ohio.

12. Socialization: Even though every attempt possible is made to socialize every kitten at the cattery, we cannot guarantee their temperament or behavior at their new home as every environment is different. If a problem or issue arises, buyer agrees to contact breeder for advice on possible solutions. Our direct contact information will be provided to Buyer, in the Kitten's paperwork, at time of Kitten pick-up/delivery information.

13. Buyer agrees that this kitten/cat will never be set loose, surrendered, re-homed, or given to anyone other than this contract stipulates. If at any time in this kitten/cats life, a situation arises where the buyer can no longer provide a home for this kitten/cat, it will be returned to the Breeder, no questions asked, to live it's life and be cared for permanently by the breeder, and not resold.

**SPAY/NEUTER AGREEMENT:**

Buyer agreed, at time of submitting their adoption application/questionnaire, to spay/neuter said Kitten.

We, Tiny Titans Cattery, are selling this Kitten to Buyer as a PET only. It is therefore mandated to be Spayed or Neutered at 6 to 7 months of age.

If Kitten is not spayed/neutered within said contractual time frame, Breeder has a right to take Buyer to account in a court of law, with the possibility of this contract being nullified and Kitten/Cat being surrendered back to Breeder, and with no monetary recompense to Buyer.

To receive your kitten's breeder slip/registration papers, microchip transfer paperwork, and a finalized contract- signed by breeder- proof of the kittens spay/neuter must first be sent to breeder. Breeder will mail all due paperwork to Buyer upon receipt.
